## Safe Exam Browser 2.1.5 for Windows released

Safe Exam Browser 2.1.5 for Windows improves mass deployment on managed computers significantly, with changes in the SEB installer and improvements in the management of config file encryption using X.509 certificates. SEB 2.1.5 also contains additional bug fixes for using specific permitted third party applications and fixes minor bugs and usability issues in the SEB Config Tool.

Carry out non-anonymous tests synced from FS (Norway)\*


*FS-tests only.* It it is now possible to carry out non-anonymous tests in Inspera Assessment.

## Manage written explanation of grades\*

Planners are now able to manage explanation of grades from within Inspera Assessment. Explanation settings are defined in Test Setup:



Explanation settings appear as a separate category in Test Setup

The new feature is extending the explanation status types from "Draft" and "Sent" to a complete life cycle:

- Not requested
- Requested Planners has requested on behalf of candidate. Grader is notified.
- Draft The explanation has been edited by a grader.
- Ready Grader marks the explanation as Done and ready to be sent by planner.
- Sent Explanation has been sent to the Candidate (Dashboard)
- Read The candidate has visited the explanation page after it was sent.

#### **Feature Highlights**

- Request explanations on behalf of one or several candidates at once
- Request explanation of all grades up front
- Control whether graders are allowed to send explanations directly
- Set deadline for explanation to be sent
- View complete log of events for each explanation
- Subscribe to notifications for all explanation events
- Monitor and filter explanation "progress" across all test

## **Export of test results available\***

Export of test results in JSON format is now available. To view a sample of available fields, <u>click here.</u> These fields will be used in a general API for exporting results, currently under development. # Transfer grades back to FS (Norway) with one click \*

Its two clicks actually, since you will need to confirm transferring all grades to FS.




After Final grading has been completed, grades (protocol) can be sent back to FS by clicking on the new "Transfer to FS" button in the Grading overview page.

#### Please note:

- For all new FS tests created in Inspera Assessment, the Grade Scale is now automatically imported at initial FS-sync and cannot be edited in Inspera, since this could brake the grade transfer mechanism with FS.
- There is a possibility that some institutions are using FS grade scale references that we have not tested. Please contact us if any issues occur.

# **Author Print Manager**

The Print Manager is now out of beta and renders Question Sets in a print friendly format.



The new print button is found next to the preview button

Print manager opens in a new tab:




Use the print manager to control visibility of Table of contents, correct answers and marks in your document.

### Feature highlights:

- Select language version to print
- Select between the following layout options:
  - Blueprint (correct answers)
  - Candidate hand-outs (questions only)
  - Custom

# Login Tabs\*

In Inspera Assessment students and admin users have separate login URLs. This has led to some confusion. You can now enable Login Tabs to make it more clear to your users, which login page they are visiting. The tabs also work as shortcuts between the pages.

#### **OTHER IMPROVEMENTS**

- Scantron batch import: TIF files are no longer allowed.
- Scantron batch import: Hiding info about tests when sketch codes are wrong
- Scantron manual import: Fixed error that could occur when uploading sketches with codes in filename.
- Demo tests: Setup page improved (non-relevant options hidden)
- Exit SEB depreciated new event "New Lockdown login"
- Possibility to show password for registered candidates (not SSO)
